

# Ultimate Trip to Brooklyn Sweepstakes

## Official Rules

**No Purchase Necessary To Participate Or Win.**

**Void Where Prohibited.**

**1) Description:** The *Ultimate Trip to Brooklyn Sweepstakes* ("**Promotion**") is a random draw promotion. Odds of winning depend upon the total number of eligible entries received during the Promotion Period. The Promotion is administered by Idea Rebel Interactive Inc (the "**Promoter**").

**2) Eligibility:** The Promotion is open to residents of Germany who are eighteen (18) years of age or older as at date of contest entry submission (each, an "**Entrant**").

Employees, officers, directors, agents and representatives of the Promoter, Brooklyn Nets, LLC ("**Sponsor**"), the National Basketball Association ("**NBA**") and its member teams, NBA Properties, Inc., and NBA Media Ventures, LLC (collectively, the "**NBA Entities**"), and each of their respective parent companies, subsidiaries, affiliates, officers, governors, owners, distributors, retailers, agents, advertising/promotion agencies (hereafter collectively, "**Released Parties**"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate in the Promotion or receive a prize.

**3) Promotion Period:** The Promotion starts at 10:00AM CET on 22 August 2024 and ends at 11:59PM CET on 8 September 2024 ("**Promotion Period**"). Registration and entries must be submitted during the Promotion Period.

**4) To Participate:** During the Promotion Period, visit <http://www.brooklynetsgermany.com/> ("**Website**") and click on the banners, buttons and/or links to access the Promotion registration page (the "**Promotion Registration**"). To register, complete and submit the Promotion Registration form according to the instructions provided. In addition, you may be asked if you wish to receive promotional emails from the Brooklyn Nets. Consenting to receive promotional emails is optional and is not required for participation in this Promotion and will not impact your chances of winning.

**There is a limit of one (1) Promotion Registration form submission per person and per email address for the duration of the Promotion Period. Additional registration forms or entries received from any such person or email address after the entry is received from that person or email address will be void.** The use of script, macro or any other device to automate or subvert the registration process is prohibited and all such registrations will be void. Incomplete entries will not be accepted and are automatically disqualified. Entries made on behalf of another person will not be accepted and joint submissions are not allowed.

It is free to register and to participate in the Promotion.

**5) Prize:** There will be one (1) Grand Prize winner (the "**Grand Prize Winner**") of the Promotion, three (3) secondary prize winners (each, a "**Secondary Prize Winner**"), and ten (10) tertiary prize winners (each, a "**Tertiary Prize Winner**").

- The Grand Prize consists of the following components, with an approximate aggregate retail value of €5,000.00 (collectively, the “**Grand Prize**”; all details and specifications related to the Grand Prize shall be determined by Promoter and/or Sponsor in their sole discretion):
  - Two (2) Economy class round trip airline tickets from the closest international airport in Germany in proximity to the Grand Prize Winners residence, to John F. Kennedy International Airport in New York City or Newark Liberty International Airport in Newark, New Jersey. Specific flight and seat selection is the sole discretion of the Sponsor.
  - Exact dates and times of flights will be determined by the Sponsor in their sole discretion
  - One (1) hotel room for two (2) in New York City for a total of three (3) nights at a 3-4 star hotel. Exact dates of hotel stay will be determined by the Sponsor in their sole discretion. Hotels and rooms to be chosen by the Sponsor in its sole discretion
  - Two (2) tickets to one (1) 2024-25 Brooklyn Nets vs. Orlando Magic game during the 2024-25 season at Barclays Center, located at 620 Atlantic Avenue, Brooklyn, NY 11217, during the Grand Prize Winner’s stay in New York City (the “**Venue**”). Specific game and tickets shall be determined by Sponsor in its sole discretion.
  - Merchandise and on-court photo
  - Grand Prize Winner can nominate one (1) friend or family member to attend with them (the “**Guest**”).
  
- The Secondary Prize consists of 1 (one) autographed Dennis Schroder jersey to be mailed to each of the three (3) Secondary Prize Winners. The Secondary Prize has an approximate aggregate retail value of €600.00 (collectively, the “**Secondary Prizes**”, each of the Grand Prize, Secondary Prize, and Tertiary Prize shall be referred to herein as a “**Prize**”).
  
- The Tertiary Prize consists of 1 (one) Dennis Schröder autographed Nets miniature basketball court to be mailed to each of the ten (10) Tertiary Prize Winners. The Tertiary Prize has an approximate aggregate retail value of €50.00 (collectively, the “**Tertiary Prizes**”, each of the Grand Prize, Secondary Prize, and Tertiary Prize shall be referred to herein as a “**Prize**”).

Any and all other costs and expenses associated with the acceptance and use of the Grand Prize or a Secondary Prize not specified herein as being awarded are the Winner's sole responsibility including, without limitation, applicable ground transportation, gratuities, merchandise, telephone calls, personal expenses of any nature for overnight layovers, meals and beverages, service charges, in-flight meals and entertainment; costs incurred to and from the departure point as the Grand Prize originate and terminate there, obtaining sufficient personal travel insurance prior to departure, if desired; obtaining and carrying all necessary travel documentation, such as passports and visas and complying with entry, health, customs and immigrations regulations and requirements.

The Grand Prize Winner and the Guest must both be at least 18 years old unless the Guest is the child or other person for whom the Winner has parental or legal guardian responsibility.

The Grand Prize Winner and the Guest are responsible for obtaining and carrying all necessary travel documentation, such as passports and visas and complying with entry, health, customs and immigrations regulations and requirements.

In the event that the Grand Prize Winner or the Guest are unable to accept the Grand Prize or are unable to travel or participate in any part of the Grand Prize for any reason, the Grand Prize Winner in question will forfeit the Grand Prize in its entirety and, time permitting, the Grand Prize will be awarded to an alternate Grand Prize Winner that will be randomly selected from any other eligible Entrants. The Sponsor retains the right to postpone or substitute the Grand Prize and the Secondary Prizes with an item(s)/activity(s) of comparable or greater value as determined solely by the Sponsor and no additional compensation prize, cash or other alternative will be awarded to the Winners in such event.

If the Grand Prize is canceled or postponed for any reason, the Sponsor will reschedule or substitute that Grand Prize(s) with an item(s)/activity(s) of comparable or greater value as determined solely by the Sponsor and no additional compensation prize, cash or other alternative will be awarded to the Grand Prize Winner in such event.

The Grand Prize Winner and the Guest must comply with all Venue rules and regulations. Failure to do so may result in the forfeiture of the Grand Prize element. Exact tickets and seat locations at the Venue for the Brooklyn Nets games are to be determined by the Sponsor in its sole discretion. The Grand Prize and the Secondary Prizes are not negotiable or transferable.

**6) Winner Determination:** At or about 5:00 PM CET on 9 September 2024 (the "**Draw Date**"), one (1) potential Grand Prize winner and three (3) Secondary Prize Winners will be selected by random draw from among all eligible entries received in accordance with these Rules (as determined by the Sponsor at its sole discretion) (the "**Winners**"). Odds of winning depend upon the total number of eligible entries received by the Sponsor during the Promotion Period.

**7) Winner Notification:** The Winners will be notified on or about 9 September 2024 by e-mail to the e-mail address provided during the registration process. Entrants are solely responsible for checking their e-mail inboxes to see if they are the Winners.

**To claim a Prize, each Winner must follow and complete the instructions in the win notification email within twenty-four (24) hours of the email notification being sent to such Winner.** If a Winner does not claim a Prize within this timeframe, such Winner's claim will be automatically withdrawn and the Sponsor will re-award the Prize to an alternate Winner selected by random draw in accordance with these Official Rules.

If a Prize remains unclaimed by 19 September 2024 at 12:00pm CET, the Sponsor reserves the right to cancel the awarding of the unclaimed Prize.

The Sponsor does not accept any responsibility if a Winner is unable to claim the Prize.

The potential Winners and the Guest (if applicable) will be required to execute and return an Affidavit of Eligibility, Liability Release and any other documents required by Sponsor within one (1) day of date of receipt of documents. The Guest (or the Winner if the Guest is the Winner's child or legal ward) must also execute and return an Affidavit of Eligibility, Liability Release and any other documents required by Sponsor within one (1) day of date of receipt of documents.

If the e-mail notifying a Winner is returned as undeliverable, or if a potential Winner is not in compliance with these Official Rules, such potential Winner will be disqualified and, time permitting, Sponsor will re-award the applicable Prize to an alternate Winner selected in accordance with these Official Rules (if one exists).

Prizes will be awarded to the person named on the applicable Promotion Registration form regardless of whether that is the authorized account holder of the email address from which said Promotion Registration form was submitted (subject to verification of eligibility and compliance with the terms of these Official Rules).

**8) Miscellaneous:** By participating in the Promotion, each Entrant accepts and agrees to accept and be bound by these Official Rules and by the decisions of the Promoter and/or Sponsor, which shall be final and binding in all respects.

No transfer, assignment, cash redemption, or substitution of the Prizes (or portion thereof) is permitted.

The Released Parties and their parents, affiliated and subsidiary companies and advertising and promotion agencies are not responsible for lost, incomplete, inaccurate, garbled, late, delayed, undelivered or misdirected entries, registrations, usernames, NBA team submissions (including but not limited to the predictions, selections or revisions); theft, destruction or unauthorized access to, or alteration of, NBA team; failures or malfunctions of phones/mobile devices (including wireless phones/handsets or other wireless devices); interrupted or unavailable network, server, Internet Service Provider (ISP) or other connections; any error, omission, interruption, defect or delay in any transmission or communication; traffic congestion on the Internet or for any technical problem, including, but not limited to, any injury or damage to Entrant's or any other person's computer or mobile device related to or resulting from participation in this Promotion; printing errors in any Promotion-related advertisements or other materials; the cancellation, suspension or preemption of NBA games, scoring tabulation or timing errors.

By entering, each Entrant agrees that the Released Parties shall have no liability and will be held harmless by Entrant for any claim, action, liability, loss, injury or damage (x) to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of any Prize, any other Prize-related activity, any travel or travel-related activity or participation in this Promotion, and (y) any and all taxes and other fees applicable to the Prize received by a Winner or the Guest. Nothing in these Official Rules shall exclude the Released Parties' liability for death or personal injury caused by its negligence or for any other matter where liability may not as a matter of law be limited.

The Released Parties, in their sole discretion, reserve the right to: 1) disqualify any person (and void his/her points) who tampers with the submission process, the operation of the Promotion, or any other component of this Promotion, or who is otherwise in violation of these Official Rules; and 2) modify to the minimum extent necessary, suspend or terminate this Promotion (or any portion thereof) should virus, bugs, non-authorized human intervention or other causes, including but not limited to war, strikes, and/or acts of God, corrupt or impair the administration, security, fairness or proper play of this Promotion. The Released Parties reserve the right to halt or modify the Promotion at any time during the Promotion Period if events beyond its control compromise the Promotion's fairness or integrity.

The Promoter and/or Sponsor reserves the right to modify these rules for clarification purposes without materially affecting the Official Rules of the Promotion. This is a Promotion designed to increase consumer awareness of and interest in the Released Parties' service.

In the event that the Promotion is challenged by any legal or regulatory authority, Released Parties reserve the right to discontinue or modify the Promotion. In such event, the Sponsor shall have no

liability to any Entrants who are disqualified due to such an action. In the event of any ambiguity(s) or error(s) in these Official Rules, the Released Parties reserve the right to modify these Official Rules for clarification purposes or to correct any such ambiguity or error(s) without materially affecting the Official Rules of the Promotion.

**9) Limitation of Liability and Disclaimer of Warranties:** IN NO EVENT WILL THE RELEASED PARTIES OR THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, REPRESENTATIVES AND AGENTS, BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING, BUT NOT LIMITED TO, DIRECT, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL ARISING OUT OF YOUR ACCESS TO AND USE OF THE PRIZES AND/OR THE PROMOTION, DOWNLOADING FROM AND/OR PRINTING MATERIAL DOWNLOADED FROM THE PROMOTION. IN NO EVENT SHALL THE RELEASED PARTIES' TOTAL LIABILITY TO YOU FOR ALL DAMAGES, LOSSES, OR CAUSES OF ACTION EXCEED \$100. SOME JURISDICTIONS MAY NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES SO SOME OF THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. CHECK YOUR LOCAL LAWS FOR ANY RESTRICTIONS OR LIMITATIONS REGARDING THESE LIMITATIONS OR EXCLUSIONS.

**10) Privacy:** Information submitted by Entrant will be subject to Sponsor's and the Promoter's Privacy Policies. The Sponsor and Promoter collect personal data from Entrants when they enter the Promotion.
